

## **Public Notice of Voting Precinct and Polling Place Changes**

The Forsyth County Board of Voter Registrations and Elections proposes to change the boundaries of certain voting precincts and change certain polling locations, as listed below. A hearing to approve a final order adopting these changes is scheduled to take place on August 3, 2021. Any person objecting to any of these changes must file his or her objections prior to August 3, 2021 at the Forsyth County Voter Registrations & Elections Office, 1201 Sawnee Drive, Cumming, GA 30040. Precinct boundary maps with polling places noted are currently on display in the Voter Registrations and Elections Office, 1201 Sawnee Drive, Cumming, GA 30040. Interested citizens are encouraged and invited to view the maps at the office. The available maps illustrate the current precinct configurations as well as the proposed modified precinct configurations and polling places.

### **Notice of Changes to Election Day Polling Places:**

The Forsyth County Board of Voter Registrations and Elections does hereby provide notice, as required in O.C.G.A. § 21-2-265 (a) of the proposed polling place changes of the Election Day precinct 29-Polo from Grace Chapel Church of Christ to Fowler Park Recreation Center located 4110 Carolene Way, Cumming, 30040 and of the Election Day precinct 37-Sawnee from Forsyth County Parks and Recreation Natural Resources Operations Center to Greater Heights Church located at 3790 Post Road, Cumming, 30040. Grace Chapel Church of Christ is no longer available as a polling place. The Forsyth County Parks and Recreation Natural Resources Operations Center is not available as a polling place for the November 2, 2021 Special Election.

### **Notice of Precinct Boundary Modifications for 07-Cumming, 08-Masburn and 16-Otwell Precincts:**

The Forsyth County Board of Voter Registrations and Elections does hereby provide notice, as required in O.C.G.A. §21-2-262 (a) and § 21-2-262 (c), of a change of precinct boundaries involving the 07-Cumming, 08-Mashburn, and 16-Otwell precincts. In order to account for property annexed by the City of Cumming, the proposed boundary modification will re-align the 07-Cumming precinct boundary to be the same as that of the City of Cumming, reassigning those affected registered voters from the 16-Otwell precinct to the 07-Cumming precinct. Currently, there are no registered voters affected by the proposed change in the 08-Mashburn precinct.

The polling place for the 07-Cumming precinct remains Cumming City Hall located at 100 Main Street, Cumming, 30040. The polling place for the 08-Mashburn precinct remains Lanier United Methodist Church located at 1979 Buford Hwy, Cumming, 30041. The polling place for the 16-Otwell precinct remains First Baptist Cumming located at 1597 Sawnee Drive, Cumming, 30040.
