
The Georgia Department of Transportation (GDOT) is nearing completion of the addition of a lane on SR 400 northbound. Once the bridge work over Lake Lanier is complete, the new northbound lane will be open in its entirety – from McFarland Parkway to SR 369. Work to add a lane to SR 400 southbound began in the spring and has a projected completion date of fall 2018.


The SR 400 widening project is funded by state funds and the voter-approved Forsyth County Transportation Bond.

At their July 20 meeting, the Forsyth County Board of Commissioners adopted the millage

rates that will fund a major portion of the county's 2018 General Fund budget, Fire District and Bonds. The board voted to maintain the county's millage rates with no change. The county's millage rate of 8.036 is one of the lowest millage rates among metro Atlanta counties.


Forsyth County staff, the Finance Committee and the of Commissioners will continue preparing the county's proposed 2018 budget, which is slated for adoption in November.

As you'll read in this month's The Current newsletter, last month your Board of Commissioners held three public hearings to discuss and ultimately vote on the county's

millage rates that will fund in large part the 2018 general operating budget. I am happy to report that the board voted unanimously to maintain the current millage rates, with a total county rate of 8.036, which remains one of the lowest in metro Atlanta.

In the coming months, county staff and officials will continue working on the proposed 2018 budget, on which a public hearing will be held later this year. I encourage you to attend this public hearing, either in person or follow along on TV Forsyth (available on Comcast channel 23, AT&T Channel 99 and at forsythco.com). You can also provide your feedback directly with your district commissioner. My hope is that you will stay engaged and informed throughout this process, as a balanced budget is the priority for our county and its citizens.
