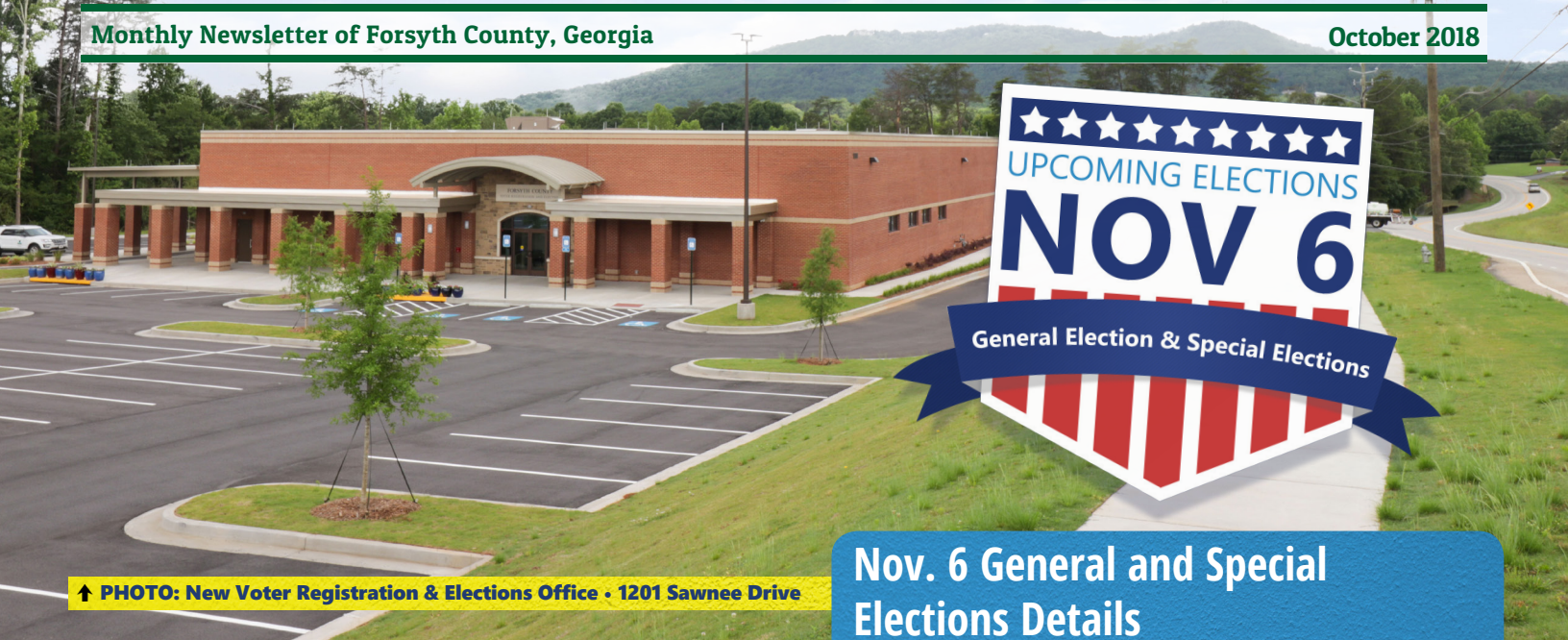

Nov. 6 General and Special Elections Details

Forsyth County residents wishing to register to vote in the Nov. 6 General Election and Special Elections must do so no later than Tuesday, Oct. 9.

Advance voting will be available weekdays for three weeks, Oct. 15-Nov. 2, and on Saturday Oct. 20 and Oct. 27. Registered voters can take advantage of advance voting for the Nov. 6 election:

REMINDER: The Forsyth County Administration Building and Cumming City Hall are no longer advance voting locations.

Registrations will be accepted online at www.forsythco.com/parks and at the county's three recreation centers located at **Central Park** (2300 Keith Bridge Road), **Fowler Park** (4110 Carolene Way) and **Old Atlanta Park** (810 Nichols Road). The registration fee is \$125 for Forsyth County residents and \$250 for non-county residents.

Commissioner's Corner




On November 6, we have the opportunity, and privilege to be at the heart of democracy by voting. One of the items on the special elections ballot is SPLOST VIII (Special Purpose Local Option Sales Tax). SPLOST is a special, one percent voter-approved sales and use tax in Forsyth County for a specified period of time (up to six years), raising revenue for designated programs or named capital projects. Forsyth County voters first approved a county SPLOST referendum in 1987, for 5 years. The one percent sales tax has been continuously extended through voter approval by referendum.

Past SPLOST programs have provided funding for a number of important infrastructure projects that otherwise may not have been possible. These include numerous transportation projects such as new roads, road widenings, intersection improvements and sidewalks; fire engines and fire stations; land for parks and green space; libraries; the county's

new courthouse, jail and downtown parking facilities; animal shelter and more.

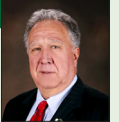
In the first quarter of 2018, Forsyth County residents were invited to provide input on projects they would like to see included in a proposed SPLOST VIII. Topping the wish list were transportation, parks, public safety (sheriff and fire), senior services, water and sewer services and libraries. Using SPLOST to help make needed investment in these and other county infrastructure projects helps ensure that we can continue to have the quality of life we enjoy in Forsyth County.

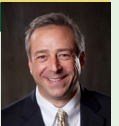

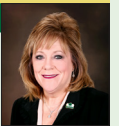

Don't Wait – Check the Date! Replace Smoke Alarms Every 10 Years

Smoke alarm safety tips:

- Smoke alarms should be replaced every **10 years**. Make sure you know how old all of the smoke alarms in your home are.
- To find out how old a smoke alarm is, look at the date of manufacture on the back of the alarm; the alarm should be replaced **10 years** from that date.
- If your smoke alarm has no date of manufacture, assume that it is beyond **10 years** old and should be replaced.
