Challenge to Elector's eligibility

Date challenge received: 03/16/2022

Name of Challenger: Frank Schneider

Electors challenged pursuant to GA Election Code section: 21-2-230

Explanation: Per the challenge: "These challenges are for the following reason: The addresses for 13 voters are business addresses. OCGA Section 21-2-216 (a) states "No person shall vote in any primary or election held in this state unless such person shall be: (4) A resident of this state and of the county or municipality in which he or she seeks to vote". Per Opinion Notes under OCGA 21-2-217, "Business address insufficient for residency purposes"

Date of Forsyth County Board of Voter Registrations & Elections (BRE) meeting/hearing: The BRE held a Special Called meeting on March 24, 2022 to hear challenges to the qualifications of voters and their eligibility to vote in the May 24, 2022 General Primary and Nonpartisan General Election pursuant to the Official Code of Georgia Annotated 21-2-230(a).

Outcome: On 03/24/2022 the BRE found probable cause to challenge the eligibility of the voters on the list to vote in the May 24, 2022 General Primary. Affected voters will be mailed a letter with information about the challenge and their options for satisfying the challenge.

Pursuant to the Official Code of Georgia Annotated (OCGA) Sections 21-2-229 and 21-2-230, as updated by Senate Bill 202 as adopted in 2021, I attest that I am a registered voter within Forsyth County. Please find my challenges to each of the 13 voters listed as email attachments along with the reason for these challenges.

These challenges are for the following reason: The addresses for 13 voters are business addresses. OCGA Section 21-2-216 (a) states "No person shall vote in any primary or election held in this state unless such person shall be: (4) A resident of this state and of the county or municipality in which he or she seeks to vote". Per Opinion Notes under OCGA 21-2-217, "Business address insufficient for residency purposes"

The research for these challenges was performed on March 11th, 12th and 13th, 2022.

The Excel data represent 9 different voter roll time slices with dates ranging from January 21, 2020 to November 17, 2021

Of the 13, 8 of them voted in either the November 3, 2020 election, the January 5, 2021 election, or both (Columns AM and AP).

Please consider this my request that a hearing be held to determine these voters' eligibility to vote within Forsyth County, Georgia.
