Challenge to Elector's eligibility

Date challenge received: 04/14/2022

Name of Challenger: Frank Schneider

Electors challenged per Election Code section: 21-2-230

Explanation: Per the challenge: "393 voters challenged under OCGA Section 21-2-229 and OCGA Section 21-2-230 due to registration in NCOA, plus sale of property at which voters and/or their family members are registered, indicating they no longer reside in Forsyth County. 114 voters are challenged under OCGA Section 21-2-230 due to registration in NCOA for property owners/renters or their voting family members indicating they reside elsewhere in Forsyth County."

Date of Forsyth County Board of Voter Registrations & Elections (BRE) meeting/hearing: The BRE held a Special Called meeting on April 19, 2022 to hear challenges to the qualifications of voters and their eligibility to vote in the May 24, 2022 General Primary & Nonpartisan General Election pursuant to the Official Code of Georgia Annotated 21-2-230(a).

Outcome: On 04/19/2022 the BRE found probable cause to challenge the eligibility of the 507 voters on the challenged voter list to vote in the May 24, 2022 General Primary and Nonpartisan General Election. Affected voters will be mailed a letter with information about the challenge and their options for satisfying the challenge.

Pursuant to the Official Code of Georgia Annotated (OCGA) Sections 21-2-229 and 21-2-230, as updated by Senate Bill 202 as

adopted in 2021, I attest that I am a registered voter within Forsyth County. Please find my challenges to each of the 507 voters, all of which are reflected in NCOA as having changed their address. These challenges are for the following reasons:

393 voters are challenged under OCGA Section 21-2-229 and OCGA Section 21-2-230 due to registration in NCOA, plus sale of property at which voters and/or their voting family members are registered, indicating they no longer reside in Forsyth County.

114 voters are challenged under OCGA Section 21-2-230 due to registration in NCOA for property owners/renters or their voting family members indicating they reside elsewhere in Forsyth County.

The research for these challenges was performed from March 15th through April 8th, 2022.

These challenges are based on the following information:

1. Forsyth County Precinct 19 voter rolls as of 11/22/2020.
2. Current NCOA data via Melissa application.
3. Forsyth County Tax Assessor online records to document property sales from Forsyth County. Links to specific voters and voting family members are provided.
4. Various state Tax Assessor online records to document property purchases in other Georgia counties or other states.
5. Various voter registration online records to document voters are registered in other states.

Please

consider this my request that a hearing be held to determine these voters' eligibility to vote within Forsyth County, Georgia.

Please note a) of the total of 3,891 registered voters, 507 are flagged as changing addresses in NCOA, b) column AK contains a link to the property sale, where applicable and c) column AL contains links to property purchase and/or voter registration information.
