

## **Forsyth County Voter Registrations and Elections**

## Challenge to Elector's eligibility

Date challenge received: <u>08/09/2022</u>

Name of Challenger: Lori Wexler

Electors challenged per Election Code section: <u>21-2-230</u>

Explanation: Per the challenge: "182 voters are challenged under OCGA Section 21-2-230 due to sale of property at which voters and/or their voting family members are registered and evidence that they reside elsewhere in Forsyth County, or property sale with unconfirmed online evidence that the voters live outside the county. For voters or family members who do not own the property at which they are registered, online evidence that they no longer reside there is provided as reason for these challenges. \*Please note that 211 of those challenged under OCGA Section 21-2-229 are also challenged under OCGA Section 21-2-230 due to the approaching date of the General Election."

Date of Forsyth County Board of Voter Registrations & Elections (BRE) meeting/hearing: <u>The BRE held a Special Called meeting on August 15, 2022 to hear challenges to the qualifications of voters and their eligibility to vote in the November 8, 2022 General Election & Special Election pursuant to the Official Code of Georgia Annotated 21-2-230(a).</u>

Outcome: On 08/15/2022 the BRE found probable cause to challenge the eligibility of four voters to vote in the November 8, 2022 General Election & Special Election. Affected voters will be mailed a letter with information about the challenge and their options for satisfying the challenge. The remaining challenges pursuant to O.C.G.A. 21-2-230 were postponed until the September 6, 2022 regular monthly BRE meeting. The BRE dismissed the challenge for 19 of the voters listed because they are no longer registered to vote at the challenged address.

Pursuant to the Official Code of Georgia Annotated (OCGA) Sections 21-2-229 and 21-2-230, as updated by Senate Bill 202 as adopted in 2021, I attest that I am a registered voter within Forsyth County. Please find my challenges to each of the 177 voters listed as email attachments along with the reasons for these challenges.

These challenges are being made for the following reason(s):

211 voters are challenged under OCGA Section 21-2-229 due to sale of property at which voters and/or their voting family members are registered and evidence that they no longer reside in Forsyth County. For voters or family members who did not own the property at which they are registered, only confirmed evidence that they no longer reside in Forsyth County is provided as reason for these challenges.

182 voters are challenged under OCGA Section 21-2-230 due to sale of property at which voters and/or their voting family members are registered and evidence that they reside elsewhere in Forsyth County, or property sale with unconfirmed online evidence that the voters live outside the county. For voters or family members who do not own the property at which they are registered, online evidence that they no longer reside there is provided as reason for these challenges.

\*Please note that 211 of those challenged under OCGA Section 21-2-229 are also challenged under OCGA Section 21-2-230 due to the approaching date of the General Election.

The research for these challenges was performed from April 4, 2022 through August 8, 2022, and except for occasional instances of birthdate not being available, the Georgia Secretary of State website was checked to rule out that the record was not already purged.

Additionally, please note that these challenges are based on the following:

- Forsyth County Tax Assessor online records
- Social media of voters themselves and that of their relatives or associates
- Information publicly available online via search engine to include real estate records outside of Forsyth county, out of state voter registration records, court records, and business and professional license filings.

Thus, consider this my request that a hearing be held to determine these voters' eligibility to vote within Forsyth County, Georgia.
