Challenge to Elector's eligibility

Date challenge received: 10/10/2022

Name of Challenger: Jeff Tormey

Electors challenged per Election Code section: 21-2-230

Explanation: Per the challenge: "All 15,787 voters are challenged under OCGA Section 21-2-230 based on determination and action by the U.S. Post Office to be "Unmailable," meaning that either the address or the ability to reach this person at this address is NOT-valid."

Date of Forsyth County Board of Voter Registrations & Elections (BRE) meeting/hearing: The BRE held a Special Called meeting on October 11, 2022 to hear challenges to the qualifications of voters and their eligibility to vote in the November 8, 2022 General Election & Special Election pursuant to the Official Code of Georgia Annotated 21-2-230(a).

Outcome: On 10/11/2022 the BRE voted to dismiss the voter challenge submitted due to a lack of probable cause.
