My name is Kerry Uerkvitz and I am a Forsyth County resident and registered voter. I am writing this letter as notice pursuant to O.C.G.A 21-2-230(a) to challenge the eligibility of Celia Cody (Date of Birth /1972) to vote in the run-off election on December 6, 2022. I am further challenging the Celia Cody's right to remain on the elector list pursuant to O.C.G.A 21-2-229.

The reason for this challenge is pursuant to O.C.G.A 21-2-217(4) "If a person moves to another state with the intention of making it such person's residence, such person shall be considered to have lost such person's residence in this state." In addition, O.C.G.A 21-2-216(a)(4) also states that "No person shall vote in any primary or election held in this state unless such person shall be (4) A resident of this state and of the county or municipality in which he or she seeks to vote..."

- This individual is a registered voter at 4845 Belcrest Way, Cumming, GA 30040. Ms. Cody sold this property to me on 6/29/2020. She no longer lives at this residence.
- The National Change of Address Registry has an address listed for Celia Cody as 3000 Blackburn Street, Apt 605, Dallas, TX 75204-2206 and was provided to the Forsyth County Board of Voter Registrations in December 2020.

Pursuant to O.C.G.A 21-2-230(b), I respectfully request the Forsyth County Board of Voter Registrations and Elections "immediately consider such challenge and determine whether probable cause exists to sustain such challenge."
