Dear Mandi,

Pursuant to the Official Code of Georgia Annotated (OCGA) Sections 21-2-229 and 21-2-230, as updated by Senate Bill 202 as

adopted in 2021, I attest that I am a registered voter within Forsyth County. Please find my challenges to each of the 13,609 voters, all of which are reflected in NCOA as having changed their address. I reviewed the entire file and was able to eliminate 59 voters who appear to have moved elsewhere within their apartment community. All previously challenged electors have been eliminated from this Voter Roll, as well.

These challenges are for the following reasons:

13,609 voters are challenged under OCGA Section 21-2-230 due to registration address different from address reflected in the NCOA database.

The research for these challenges was performed during May, 2022.
