Public Notice of Election Day Voting Precinct and Polling Place Changes

(to run in the Forsyth County News on 2/19, 2/22 & 3/1/2022)

The Forsyth County Board of Voter Registrations and Elections (BRE) proposes to change the boundaries of certain voting precincts resulting in the creation of an additional precinct and an additional Election Day polling place and the elimination of a third precinct. On February 11, 2022 the BRE approved a series of precinct and polling place changes as they were advertised in January 2022. Two facilities are no longer available for use as polling places; therefore, it is necessary to adjust for these changes. A hearing to approve a final order adopting these changes is scheduled to take place on Thursday, March 24, 2022 at 8:00 a.m. at the Forsyth County Voter Registrations and Elections Office. This meeting is open to the public. Any person objecting to any of these changes must file his or her objections prior to March 24, 2022 at the Forsyth County Voter Registrations & Elections Office, 1201 Sawnee Drive, Cumming, GA 30040 or by email to Voter@forsythco.com. Precinct boundary maps with polling places noted are currently on display in the Voter Registrations and Elections Office, 1201 Sawnee Drive, Cumming, GA 30040 and online at www.forsythco.com/vote. Interested citizens are encouraged and invited to view the maps at the office and/or online. The available maps illustrate the current precinct configurations as well as the proposed modified precinct configurations and polling places. The county advises that minor modifications of precinct lines may occur pursuant to Redistricting legislation pending in the General Assembly.

If approved, the proposed changes will result in a total of 28 Election Day precincts and polling places and will be in effect starting with the 2022 election cycle. The proposed precinct changes are listed below in precinct order.

Notice of the Addition of a new Precinct and Polling Place:

The Forsyth County Board of Voter Registrations and Elections does hereby provide notice, as required in O.C.G.A. §21-2-262 (c) and 21-2-265 (a), that the following may be assigned as a new precinct and new polling place. The boundary lines of the proposed new precinct may run as follows:

49-Cheatam Creek Precinct: From Canton Highway and Cheatam Creek; south along Cheatam Creek to Bethelview Road; Bethelview Road north to Drew Road; Drew Road west to perennial stream near Carramore Drive; Following the perennial stream north to Aaron Sosebee Road; Aaron Sosebee Road north to Canton Highway; Canton Highway east to Cheatam Creek. All voters assigned to the 49-Cheatam Creek precinct will vote at Saint Raphael, Nicholas, and Irene Greek Orthodox Church located at 3074 Bethelview Road, Cumming, GA 30040.

Notice of Precinct Boundary Changes:

The Forsyth County Board of Voter Registrations and Elections does hereby provide notice, as required in O.C.G.A. § 21-2-262 (c), that the boundary lines of the following precincts may be changed to run as follows:

The proposed precinct and polling place changes will consolidate some of the 45-Mountainside precinct into the proposed 49-Cheatam Creek precinct.

45-Mountainside Precinct: From Tribble Road and Watson Road, east on Watson Road; Watson Road east to McConnell Road; McConnell Road east to Aaron Sosebee Road; Aaron Sosebee Road east to Hurt Bridge Road; Hurt Bridge Road north to Pleasant Grove Road; Pleasant Grove Road northeast to Dr Bramblett Road; Dr Bramblett Road north to Settingdown Creek; Settingdown Creek south to John Burruss Road; John Burruss Road south to Thalley Creek; Thalley Creek east to Twin Lakes Road; Twin Lakes Road south to Spot Road; Spot Road west to Bettis Tribble Gap Road; Bettis Tribble Gap Road south to the boundary of Sawnee Mountain Preserve; Following the boundary of Sawnee Mountain Preserve south and west to Tower Road; Tower Road south to Canton Road; Canton Road north to ephemeral stream; Ephemeral stream south to Greenwood Acres Drive; Greenwood Acres Drive south west to Chamblee Gap Road; Chamblee Gap Road west to Cheatam Creek; Cheatam Creek north to Canton Highway; Canton Highway west to Tribble Road; Tribble Road north to Watson Road. All voters assigned to the 45-Mountainside precinct will vote at Friendship Baptist Church located at 2250 Friendship Circle, Cumming, GA 30028.

The proposed precinct and polling place changes will consolidate the 48-Silver City precinct into the 06-Crossroads precinct and the 27-Concord precinct.

06-Crossroads Precinct: From Keith Bridge Road and Martin Road, north on Martin Road across Georgia Highway 400 to Dahlonega Highway; Dahlonega Highway north to Settingdown Creek; Settingdown Creek east to Georgia Highway 400 north; Georgia Highway 400 north to the county border north (Dawson county); County border north (Dawson county) east to Lake Lanier (eastern county border); Lake Lanier south to Dawsonville Highway east; Dawsonville Highway east to Westbrook Road west; Westbrook Road west to Jot Em Down Road north; Jot Em Down Road north to Mayfield Drive south; Mayfield Drive south to Mayfield Lane south; Mayfield Lane south to Cantrell Circle west; Cantrell Circle west to Keith Bridge Road west; Keith Bridge Road west to Martin Road. The polling place for the 06-Crossroads precinct remains Hampton Park Library located at 5345 Settingdown Road, Cumming, 30041.

27-Concord: Georgia Highway 400 at County Border (w/Dawson County) south to Settingdown Creek; Settingdown Creek south and west to Dahlonega Highway; Dahlonega Highway north to Oak Grove Circle; Oak Grove Circle northwest to Squattingdown Creek; Squattingdown Creek west to Matt Highway; Matt Highway west to Dr Bramblett Road; Dr Bramblett Road south to Settingdown Creek; Settingdown Creek west to Burnt Bridge Road; Burnt Bridge Road north to Wallace Tatum Road; Wallace Tatum Road west to Seabolt Drive; Seabolt Drive north to Matt Highway; Matt Highway southwest to County Border (w/Cherokee County). The polling place for the 27-Concord

precinct remains Concord Baptist Church located at 6905 Concord Road, Cumming, 30028.
