SHARON SPRINGS TAG OFFICE
TO TEMPORARILY CLOSE FOR RENOVATIONS

Project is focused on enhanced customer service

FORSYTHCOUNTY, Georgia – On August 1, 2015, the Sharon Springs branch of the Forsyth County Tax Commissioner’s Office, which is located inside Sharon Springs Park, is scheduled to temporarily close for renovations. The project will involve increasing the size of the lobby/waiting area as well as a redesign of the customer service counters. The remodeling will bring additional seating while allowing for future growth and better management of customer flow.

Forsyth County Tax Commissioner Matthew Ledbetter is excited about the renovation.

“We appreciate the patience of our citizens during this renovation, as we strive to accommodate the needs of our growing community,” said Ledbetter. “Once complete, the increased space and redesign will allow us to provide a greater customer service experience for everyone, which continues to be our highest priority.”

First opening in 1999, this is the first expansion or redesign of the Sharon Springs branch.

Renovations are expected to take approximately six to eight weeks to complete. An official reopening date will be determined and announced closer to completion.
