First section of new SR 400 southbound lane OPEN TO TRAFFIC!

Progress on the widening of State Route 400 in Forsyth County continues! The first section of the new SR 400 southbound lane – between SR 141 and McFarland Parkway – opened to traffic on December 22.

Construction will continue widening SR 400 from SR 369/Browns Bridge Road to SR 141/Peachtree Parkway. Weather permitting, that section is expected to open to traffic in late spring 2018.

The SR 400 widening project – adding a lane in each direction of SR 400 from McFarland Parkway to SR 369 – is being made possible through a partnership between Forsyth County and the Georgia Department of Transportation. GDOT has contributed funding to this work and is managing the project. The remainder of the project funding comes from the Forsyth County Transportation Bond approved by 63 percent of Forsyth County voters in 2014.

It's easy to get excited about being a part of a community with a wonderful quality of life and bright future. The Board of Commissioners is committed to working hard to continue to make Forsyth County the ideal place to live not just for 2018, but for many years and generations to come.


