# SR 369 & 400 PROJECTS FACT SHEET

#### Project Description

The project will widen SR 369 (also known as Brown's Bridge Rd.) from a two-lane road to a

Project Extends to SR 9 four-lane road, divided by a 20-foot raised median. There will be a partial cloverleaf interchange at SR 369 and SR 400. The road will be widened from just west of SR 9 to slightly east of SR 306, a distance of approximately 2.0 miles. The project will also include an 8' enhanced sidewalk trail along the south side of SR 369, with a five-foot sidewalk along the north side.

#### Construction Steps

The steps for the SR 369 widening and SR 400 interchange include, but are not limited to, the following activities:

- •Right of Way Acquisition (Est. November 2017 to December 2019)
- •Final Plans Complete (August 2019)
- •Construction Contract Bid (December 2019 Bid Letting)
- •Construction Complete (Spring 2023\*)

## Traffic Control During Construction

Stage construction and various types of traffic control devices will be used during the construction period (approx. 36 months\*). Temporary lane closures may be required during the different stages of construction.

#### **Funding for the Project:**

The extension was identified in the Forsyth County Major Transportation Plan of 2006. In 2014, Forsyth County voters approved a general obligation bond of up to \$200 million dollars to finance transportation projects, including the widening of SR 369 and cloverleaf interchange at SR 369 and SR 400. The project is joint project between Forsyth County and the Georgia Department of Transportation (GDOT). GDOT has currently obligated \$16 million to the project and Forsyth County set aside \$33 million in its 2014 bond referendum.

#### **Funding - Current Status:**

Now in its final stages of pre-bid activities, the SR 369 widening and cloverleaf interchange at SR 369 and SR 400 is projected to be sent out for bid in December 2019. The design plans are completed, and right-of-way parcels are being acquired. Final estimated construction cost is \$58 million.
