In Forsyth County, House District 24 encompasses portions of the following six precincts:

Coal Mountain precinct: Coal Mountain Park Community Building, 3560 Settingdown Rd, 30028; Cumming precinct: Cumming City Hall, 100 Main St, 30040 (All Cumming precinct voters are eligible to vote in the City Council election; a portion are also eligible to vote in the House District 24 election), Midway precinct: Midway Park Community Building, 5100 Post Rd, 30040; Heardsville precinct: Sawnee Mountain Park Community Building: 3995 Watson Rd, 30028; Otwell precinct: First Baptist Cumming, 1597 Sawnee Dr, 30040; and Polo precinct: Grace Chapel Church of Christ, 6755 Majors Rd, Cumming, 30040.
